To: Adjoining Landowners to the proposed Deerfield Wind Project (per attached list)

Re: Petition of Deerfield Wind, LLC for a Certificate of Public Good pursuant to 30 V.S.A. sections 231 and 248, authorizing it to construct up to a 45 MW wind electric generation facility, and associated transmission and interconnection facilities, in Searsburg and Readsboro, Vermont, and operate the same.

By letter dated January 8, 2007, Deerfield Wind, LLC notified you that it had submitted a Petition and supporting materials to the Vermont Public Service Board for approval of a wind energy project in Searsburg and Readsboro, Vermont. 
