IN CONSIDERATION OF THE FEE PAID, THE REGISTERED WEIGHT OF THIS VEHICLE IS DEEMED TO BE INCREASED TO THE WEIGHT AND CONDITIONS SHOWN ON THIS PERMIT. EXCEPT FOR VEHICLES REGISTERED AND TRAVELING IN MASSACHUSETTS, WHICH MUST BE REGISTERED FOR THE VEHICLE GROSS WEIGHT. Note: Failure to comply with all individual Agreement State and municipal laws, rules and regulations invalidates this permit. All bridge weight and height limits, as posted must be observed.
